Howick traffic officer sentence for fraudulently issuing learner driving licences

GAUTENG: The Durban Specialised Commercial Crimes Court has sentenced a 47-year-old traffic officer to four years imprisonment or a fine of R10 000 for fraudulently assisting learner licence applicants to pass tests at Umngeni licensing department in Howick, KwaZulu Natal.

The court said Mr S'khumbuzo Mkhulise deserved direct imprisonment for his crime. However, it took into account the fact that he had pleaded guilty and had shown remorse.

Mr Mkhulise was further placed under correctional supervision for three years and will be required to remain under house arrest, do community service and undergo a rehabilitation programme.

He was also instructed not to commit fraud, corruption, theft or any other crime for five years and not to consume alcohol or use any narcotic drugs.



Mr Mkhulise's sentencing relates to a raid conducted by the National

Traffic Anti-Corruption Unit – an entity of the Road Traffic Management

Corporation - and the Hawks at the Umngeni licencing department in

March 2018. Fifteen people – including learner licence examiners and

nine learner licence applicants - were arrested on the day on allegations

of fraud. More people - including a driving school operator, a former traffic

chief, and an administration clerk – were later arrested following intensive

investigation bringing the total number of suspects to twenty (20).

It has been alleged that learner licence examiners at the department

unlawfully and fraudulently assisted learner licence applicants to pass

learner licence tests. It has been established that in one month (January

2018) more than 500 applicants unlawfully benefitted from the fraud

perpetrated by officials at the department.

The Umngeni local municipality has dismissed the accused officials

following lengthy disciplinary processes. Their trial is still pending at the

Durban Specialised Commercial Crimes Court.

Mkhulise was found guilty and dismissed from employment in September

last year. The chairperson of the disciplinary hearing found that "the

employee had clearly illustrated his remorse by pleading guilty and

acknowledging the wrongfulness of his actions".

It was found that the fact that he had worked for 15 years as a traffic officer

before being appointed as an examiner of learner licences was an

aggravating factor.

"Given his years of experience, he ought to have known better," the

chairperson said. "He may have gotten caught committing the offence on

his first and second days on the job as a newly accredited examiner, but

that does not detract from the fact that he committed a grossly dishonest

act that ultimately would have no other consequence but destroy the

employment relationship with his employer to the extent that even

redeployment to another section cannot repair it," the chairperson

concluded.

"Although we had wished for a harsher sentence, we, however, accept the

outcome of the court," said RTMC CEO Advocate Makhosini Msibi. He

said Mr Mkhulise will never be able to work in the law enforcement sector

again and this means one rotten apple has been removed from the

system.

He urged members of the public to join the ongoing campaign against

fraud and corruption in the traffic sector by resisting to pay bribes and to
