Vehicle fleet owners and company representatives sought in connection with Mpumalanga's R60 million vehicle licence disk fraud

Mbombela: The National Traffic Anti-Corruption Unit and the Hawks are this morning going out to arrest fleet vehicle owners and representatives of companies suspected of involvement in Mpumalanga's R60 million vehicle licence fraud.

This follows the arrest of 14 (fourteen) officials earlier this year, who included former employees of the Mpumalanga department of community safety, security and liaison based at the Natis helpdesk and staff members from various registering authorities including Mbombela, Piet Retief, Lydenburg and Delmas.

It is alleged that the fleet owners and company representatives conspired with the officials to have vehicle licence fees and arrears, worth millions of rands,





written off. Vehicles discs indicating zero amounts owed would then be issued to owners. In exchange, the owners or representatives would deposit 50% of the amounts owing into the personal accounts of the officials as gratification.

If found, the owners and company representatives would appear in court tomorrow (14 December 20220) for bail application.

The officials were in court last week (06 December 2022) and their case was postponed to 21 February 2023. They are out on R15 000 bail each. They have been charged with fraud, corruption, and money laundering.
