## **ROAD TRAFFIC MANAGEMENT CORPORATION CRACK DOWN ON ERRANT FLEET OPERATORS CONTINUE**

**PRETORIA** – The Road Traffic Management Corporation (RTMC) is intensifying its drive to deal with freight and public transport operators that are flouting national road traffic regulations and are engaging underhanded methods to licence vehicles.

The RTMC team comprising National Traffic Police and National Traffic Anti-Corruption Unit will pounce today on these businesses as part of Operation Kwanele (enough is enough) to conduct inspections and serve letters of demand on operators that are owing millions of rands in unpaid vehicle licence fees.

The RTMC has identified about 24 companies that owe the state more than R16.9 million in vehicle licence fees, arrears and penalties. These are related to more than 1778 vehicles – trucks, trailers and busses – that were supposed to have their vehicle licences renewed in the Free State in the past three years.

Ten companies owing R8.6 million were visited in Gauteng last week and letters of demand were served where company representatives were available to receive them. The campaign will move into Mpumalanga, KwaZulu Natal and the Free State today and about 13 companies will be visited simultaneous in co-ordinated raids with the aim of inspecting premises and demanding payment for outstanding fees.
