### **A LICENSING OFFICIAL ARRESTED ON CHARGES OF FRAUD AND CORRUPTION RELATING TO FOREIGN NATIONALS**

**GAUTENG--:** A Limpopo examiner has been arrested by the Road Traffic Management Corporation's (RTMC) National Traffic Anti-Corruption Unit (NTACU) at Lebowakgomo Licensing Centre for allegedly assisting four learner licence applicants get learners licenses without them being tested. Three of the four applicants are foreign nationals who cannot read, write or speak English.

The examiner was caught red handed assisting the applicants in the classroom during an exam. Upon further investigations and questioning, the applicants confessed to paying a fee of R3000 each to the examiner.

All suspects have been detained at Lebowakgomo Police Station and are due to appear in court. Investigations continue with more arrests expected.
